## **EXECUTIVE SUMMARY**

RubinBrown, LLP (RubinBrown) performed a Cyber Security Assessment of RDR Investments LLC environment in June 2020. The assessment was designed to identify gaps and vulnerabilities within the security program that could result in unnecessary risks to the information technology infrastructure, organizational processes or sensitive information. We focused on specific areas within RDR Investments LLC's environment as defined by management.

The Cyber Security Assessment included the following components:

- 1) External Vulnerability and Penetration Test
- 2) Internal Vulnerability Assessment

The report, recommendations and supporting attachments are designed to be used by RDR Investments LLC to make relevant decisions on improving information security in the above-noted areas, as well as the enterprise security program.

### **Summary of Observations**

The following were observations from the Technical Security Assessment:

- Insecure configurations exist on the internal network\*
- Insecure protocols are in use on the internal network\*
- Weak encryption is in use\*

\*The security vulnerabilities identified during the assessment were remediated by RDR Investments. Follow-up testing verified the remediation efforts and did not identify new vulnerabilities.

### **Recommendations**

RubinBrown recommends RDR Investments LLC implement the following recommendations to improve the security of the environment:

1. Address identified vulnerabilities and re-test to ensure vulnerabilities are remediated (completed).
2. Implement a vulnerability management program that includes periodic internal and external vulnerability, and penetration testing. Given the environment and operational use of technology, we recommend performing semi-annual external testing and internal vulnerability scans (ongoing).
